

# MINUTES OF MONTHLY MEETING OMRO TOWN BOARD OF SUPERVISORS

# February 18, 2019

#### 1. Call to Order:

The meeting was called to order at 6:0 P.M. by Chairman, Brian Noe. The Pledge of Allegiance to the flag was given.

### 2. Roll Call:

Chairman Brian Noe, Supervisors, Allen Knurr and David Friess, Clerk Paula Beulen, Treasurer Beth Jackson and Attorney, Karen Marone were present.

### 6. <u>Update from QOS Fiber on proposed internet service.</u>

• Chairman Noe has not heard from QOS. Will carry the item over to next month.

# 7. Discuss action related to Winnebago County zoning amendment to Sawyer Creek Floodplain map.

- The City of Oshkosh hired Martensen & Eisle to do a drainage study of Sawyer Creek. As a result of this study they created a potential map of the area. The impact to the Town of Omro is not great but it could cause a resident with property in those areas to get numerous permits if they want to use their land for anything other than cropping.
- This amendment impacts the Town negatively and does not improve the Town drainage at all. The Planning Commission recommends that the Town contact Winnebago County and let them know that we do not want this map approved.
- The Planning Commission also recommends that the Town contact FEMA and let them know that we are opposed to the proposed detention basin in our Town.
- The PC Chair also stated that all of the Towns involved in this proposed map are advisory only and do not have any veto power but the County would like to hear the Towns opinions.
- MOTION: Supervisor, David Friess moved to approve that we send notice to Winnebago County letting them know the town is not in favor of the potential map. We will also send notice to FEMA that we are not in favor of the potential map. Supervisor, Allen Knurr seconded the motion.

#### 8. Discussion on Proposed City of Omro Future Land Use Plan map.

- The Town will talk to the City and let them know that there are some other areas adjacent to the City that are better options for them then the proposing Town of Omro land.
- The City's own data shows that they have plenty of room for the projected growth for residential without going outside of city limits.

- PC Chair will communicate with the City Administrator and City Mayor what the town has decided.
- MOTION: Supervisor, Allen Knurr moved to have the board contact the City of Omro to recommend removal of the parcels on the East side of the side, removal of the eastern most industrial use parcels and removal of the future roads of these sections. Supervisor, David Friess seconded the motion.
