



MINUTES OF MONTHLY MEETING OMRO TOWN BOARD OF SUPERVISORS

February 15, 2021

Call to Order:

The meeting was called to order at 6:00 P.M. by Chairman, Brian Noe. The Pledge of Allegiance to the flag was given.

1. Roll Call:

Chairman Brian Noe, Supervisors, Mark Krings and David Friess, Treasurer Beth Jackson, Clerk Carey Carley, and Attorney, Karen Marone were present.

2. Statement of Public Notice:

Notice of this meeting was posted at the Omro Town Hall and the Town website. The Omro Herald and Oshkosh Northwestern were notified via email.

3. Public Input:

- Resident Brian Seaman- gave input regarding hiring a deputy clerk and asked questions regarding meeting with assistant district attorney.
- Resident Marlena Ross- asked questions regarding a town audit and gave input on hiring a deputy clerk.

4. Community Policing Discussion:

5. CSM: The Katherine Bieble TST, Katherine L Faust, Carice M Faust, Gordon D Faust and Marcia J Faust, are petitioning for a CSM to parcel 0160311 located at 4143 Reighmoor Road.

- After much discussion between board members, parties listed, and Rich Kern, a motion was made to approve CSM 01610311, creating a 5-acre lot with appropriate zoning from Winnebago County.
- **Motion to approve:** Supervisor, David Friess made the motion. Supervisor, Mark Krings seconded the motion.

6.Zoning Change: Regarding Faust CSM. Applicants are also requesting a zoning map amendment from A-2 & R-1 to A-2 & R-2 (or other appropriate category) in order to create a residential lot. The zoning application was submitted to the County for their January 26, 2021 meeting.

7. CSM: Paul A. Derber as Trustee for the Paul A. Derber Rev. Testamentary Trust and WI Tubing Properties LLC are the petitioners of a CSM combining a portion of parcel 016-0547with parcel 016-054704.
