Approve Minutes

Priske Park Recommendations

- 1) Friends of the Park to clean paths already made by ATVs.

- 2) Purchase a small amount of Round Up or its equivalent.

- 4) Post park against motorized vehicles

MOTION: Barbara Meyers moved to recommend that the Omro Town Board post signs stating that no motorized vehicles are allowed in the park. David Friess seconded the motion. Motion carried.
