TOWN BOARD MEETING FEBRUARY DATE MOVED

The February meeting of the Town of Omro Board of Supervisors will not be on the usual third Monday of the month. It is scheduled for the fourth Monday, February 27, 2023, with its usual 6:00 P.M. starting time.

PRIMARY ELECTIONS

On Tuesday, February 21, 2023, there will be a primary election for a position on the State Supreme Court. This is a non-partisan race and the field will be paired down to two candidates from this primary to run in the April 4, 2023, election.

All wards in the Town of Omro will have the same ballot. Voters can cast one vote from among the four candidates. The choices are in this order: Janet C. Protasiewics, Daniel Kelly, Everett Mitchell and Jenifer Dorow. There is no announced write in candidate so no names written into the ballot will be counted.

Absentee ballots can be expected in the mail now if the request was made in a timely manner. Absentee ballots can still be requested until Friday, February 17.

VOTING AN ABSENTEE BALLOT IN PERSON

You may also request and vote an absentee ballot in the clerk's office during the days and hours specified for casting an absentee ballot in person.

The first day to vote an absentee ballot in the clerk's office is Tuesday, February 7, 2023.

The last day to vote an absentee ballot in the clerk's office is Friday, February 17, 2023.

No in-person absentee voting may occur on the day before the election.

In-person absentee voting may take place at the Clerk's office on

Mondays, Noon - 4 pm

Wednesdays, 9 am – Noon

Or by Special Appointment (must be scheduled 48 hours in advance)
