## **MAY 15, 2023, TOWN BOARD MEETING**

There was no public comment.

The Board did the following:

Announced that Brenda Pulchinsky has been appointed treasurer for the Town. She has been hired as Deputy Clerk previously.

Discussed the ramifications of the motions passed at the annual meeting of electors concerning the potential purchase of cemetery land. They took no action, still concerned that they have no definitive answer as to where remains might be located in the area that might be sold. They are also waiting for information from the potential buyer concerning the role of the Wisconsin Historical Society.

Adopted a schedule of road work to be accomplished this summer and fall.

Announced that the Plan Commission will begin doing the five-year update of the Comprehensive Outdoor recreation (COR) Plan.

Approved minutes of a Special Meeting on April 26 and of the regular meeting on April 17.

Adjourned at 7:09 without going into closed session.
